





### **Send your comments on EIA Draft Notification 2020**

On June 30, Delhi High Court, while responding to a petition filed by environmentalist Mr Vikrant Tongad, deferred the last date for filing objections to the draft EIA notification 2020 to August 11.

17,000 Indians have already taken a stand on the draft EIA notification 2020 despite being in lockdown. We need at least 10,000 more emails sent to let the Environment Ministry know that they are doing wrong by prioritizing business over the environment!

From excluding new industries that should have environmental clearance to reducing the number of public consultations, the draft EIA 2020 notification goes against the need of the hour to strengthen environmental laws.
