#### Dear friends

Greetings! We write to you with news, articles, and reports from the third quarter of the year. You might remember that our last newsletter announced Climate Action Month 2024 (CAM). You might have even been a part of the activities. As anticipated, CAM was eventful, exciting and meaningful. With around 30 events (including music, drama, documentaries and workshops), we were able to reach thousands of Chennai-ites with the message of sustainability. Our work on climate awareness continues in other forms, and you will be seeing more climate action from us in the months to come!

Our participation in the INCs towards a legally binding global treaty to address the plastic crisis continues, as we ready ourselves to attend INC-5 in South Korea. Single-use plastics (SUPs) and their fossil fuel heritage remain key players on the climate change scene. Any policy or intiative aimed at driving out SUPs out of our economy and ecosystem needs to be evidence based. CAG's assessment of the Tamil Nadu government's Meendum Manjappai campaign is one such effort designed to obtain data, assess effectiveness and share it with policymakers.

In a similar vein of supporting effective policy-making, CAG's assessment of the usage and availability of child helmets in Chennai was designed to elicit data, and offer analysis to policy makers. Both reports are in this edition of our newsletter.

Consumer protection, both via one to one support to aggrieved consumers, and via our many workshops continues. We continue to ask for a more effective Front of Pack Labelling legislation. We believe that such regulations will help consumers make more informed food decisions, directly impacting their own health and at a macro-level, the health of communities and the nation itself.

Our work on electricity governance across various states in India has been very well received. We have held a series of meetings with citizens and electricity officials, as we aim to bring together awareness and accountability.

Our electricity audits have continued, as we help small scale industries, workshops and factories critically analyse their energy needs and expenditure. These audits are followed by a written report with recommendations to help these businesses cut down on their energy consumption.



# THE HELMET CONUNDRUM A report on child helmet usage and availability in Chennai

## **Evaluating the efficacy of the Meendum Manjappai campaign**

This report details CAG's findings on the impact of the Meendum Manjappai campaign on both consumers and vendors, with the study covering eight districts in Tamil Nadu. Meendum Manjappai is a flagship campaign of the Government of Tamil Nadu which promotes the use of cloth bags, thus reducing the reliance on single-use plastic (SUP) carry bags in the state.

The Helmet Conundrum: A study by CAG surveying 520 parents and 145 helmet shops in Chennai reveals that only 25% of children wear helmets, with 12% using adult helmets. Shocking findings considering that children are amongst the most vulnerable of road users and the parental instinct is to prioritise safety of their children, even over their own.
