Our anniversary event to celebrate this milestone was as introspective as it was celebratory, offering a moment to reflect on our journey while showcasing each of our current areas of work. The event was graced by Justice K.P. Sivasubramaniam (Retd., Madras High Court), Mr. K. Phanindra Reddy, IAS (Retd.), Mr. Girish, IFS – Assistant Mission Director, Tamil Nadu Climate Change Mission, Mr. N. Murali, Director of The Hindu Group, and several of our Board Members.

To commemorate the occasion, we also released a souvenir—attached to this newsletter—which captures highlights from CAG's work and impact over the years.

Our work reflecting our commitment to a sustainable future continues through events, research, reports, and social media initiatives. Our recent report on enhancing sustainable mobility around school zones examines the vicious cycle of unsafe roads, which often leads parents to rely on motorised transport for their children. The event marking the report's release also provided a platform for students to share their perspectives on what a safe school journey

means to them. Meanwhile, our efforts to make roads safer are ongoing, as we engage with policymakers on planning and protocol measures. If implemented, these measures have the potential to significantly improve road safety standards across the State.

Green Action Week 2025 was celebrated with the usual energy and enthusiasm as we encouraged young people to adopt sustainable lifestyles through several events in city schools and colleges.

Our work in electricity governance now aligns perfectly with our efforts to promote sustainable energy use. Over the past few months, we have conducted a series of workshops across the city to encourage rooftop solar adoption. In parallel, we have been carrying out energy audits in both private and government buildings across the state. Each audit—if its recommendations are fully implemented—has the potential to reduce greenhouse gas emissions and lower energy costs for communities.

As we have for the last 40 years, we remain committed to consumer protection as we work to improve consumer awareness and ensure our collective voices are heard, both through policy advocacy, and more practically, through our grievance redressal help desk services.


