

A meeting was conducted to review road safety issues and remedial measures to be taken by the Committee. The list of participants is enclosed. The following aspects were discussed.

1. Intensive Accident Care Wards to be provided in all Government Hospitals and private hospitals exclusively to treat road accident victims to reduce fatality due to accidents. The Deputy Director, Medical Education has informed that Infection Control Committee will be formed in all the major hospitals in Chennai City. It was emphasized that accident victims should be given treatment immediately with all possible medical facilities. Since GST Road is prone to accidents, a Trauma Care in the area covering GST may be made available. Top priority should be given to road accident victims by providing a dedicated team especially in Chrompet Government Hospital. Likewise, required facilities should be made available for victims of accidents in ECR and OMR. Deputy Commissioners of Police, Traffic were instructed to study the accident pattern road wise and Trauma care centres can be installed according to the necessity.

2. DCs Traffic

2. Traffic Education Parks need to be constructed in the city. Deputy Commissioners of Police, Traffic will make a study on how much space is required for a park and can send the Proposal to the Greater Chennai Corporation authorities. Police and Corporation authorities may identify parks where construction of Traffic Education parks is possible. Displays as well as audio and visual programmes may be made available inside the parks as part of Traffic Education programme.

With regard to the Installation of CCTVs in outer peripheral areas, Policy decision has to be taken.

Cattle menace in the entire Chennai City to be eradicated to prevent accidents and facilitate vehicle movements.

3. It was informed by Greater Chennai Corporation authority that a survey is being conducted by a private agency to provide Parking Zones in Chennai City and that the work will be completed by July.

Action by Corporation

4. Removal of encroachments on Arterial Roads should be a continuous process. Greater Chennai Corporation authorities may contact the Nodal Officer of Traffic Wing and take necessary action for removal of encroachments. Joint Commissioner of Police, Traffic, North and South are nominated as nodal officers for the concerned jurisdiction. They can liaise with corporation, Law and Order, Armed Reserve and supervise the execution of encroachment in their jurisdiction

5. It was informed that major part of the road space near Gaiety Theatre in Chinthadripet is encroached by auto rickshaw workshops and other shop owners leaving little space for road users. Even the MTC bus drivers find it difficult to cross the stretch. Removal of encroachment is requested.

6. A study can be made on the feasibility of raising the height of centre median as well as closure of gaps in between centre medians. Wherever openings are available for pedestrians, it should be visible for the drivers as a precautionary measure. It was suggested to provide openings at a certain distance on OMR to facilitate pedestrians.



In order to facilitate fast movement of vehicles in Toll Plaza posting of additional Man power and lanes may be facilitated. Idea of utilizing debit/Credit cards may be studied to speed up the process of payment.

It is assured that delineators in the Anna flyover will be erected within a week.

Action by Highways

7. Since illuminations on some stretches of Highways are poor, necessary initiatives should be taken for improvement. Places have to be identified and action has to be taken.

Requirement of reflective signages can be assessed and provided to the Highways for necessary action.

8. CEO may conduct meeting with school authorities to insist that students should not be allowed to ride two wheelers. Parents should also be warned appropriately.

Road Safety Awareness programmes should be conducted regularly in schools to educate school students about road discipline. CEO can give instructions to the Head Masters/ Principal to take initiative in organizing Road Safety Education programmes.

It is emphasized that school authorities have to be asked to utilize the available school ground by allowing the vehicles inside the school premises to drop / pickup the children to avoid traffic congestion on the roads near school premises. RSPs in the Schools may be utilized properly.

2. DCs, Traffic

9. Conductors to be posted in all school buses / Vans to ensure safety of the children as well as to prevent accidents.

In order to prevent footboard travelling, MTC authorities should insist the drivers to keep the doors closed when plying. MTC authorities should see that doors

are provided in all buses and that they are well maintained. The drivers should be advised not to use cell-phones while driving and cautioned against jumping signals. (567)

In Velacherry, MTC buses have to use the bus bay available in Vijayanagaram bus shelter to ease out the congestion.

Action by M.T.C

10. No representative from Transport Department attended the meeting. The Joint Transport Commissioner who is also a Member of Committee may attend the next meeting.

11. Teams should be formed in all zones comprising of members of Greater Chennai Corporation, Police Department, Electrical, Highways and other stake holders in order to improve road engineering.

12. Campaigns and Orientation programmes should be organized for all categories of road users as a road safety measure.

A meeting was convened to review issues affecting road safety and remedial measures to be taken up by the Committee. The following issues were discussed.

**I. Intensive Accident Care Wards** : With regard to provision of Intensive Accident Care Wards in all government and private hospitals, the concerned DCs (Traffic) have identified certain accident prone roads which are listed in **Annexure I**.

It was informed that for the primary care level and secondary care level, 108 ambulance service is provided. Adequate network facilities are also available. A separate Trauma Care Cell will apparently be started under the Transport Commissioner's control. The Transport Commissionerate Committee includes one doctor. The Government of India is also extending their support by providing Trauma Care Centres based on the black spots / accident prone areas. Initially it was extended to the Golden Quadrilateral corridors but now other hospitals are also covered.

DCs (Traffic) will ascertain in how many places this facility is available and where it is not available. Once the DCs come to know about places where this facility is not available, they will send a proposal by 10.5.2017 to provide these facilities. Once specific hospitals are identified, they should be advised to provide treatment to accident victims.

**Action - DCs / Traffic and DMS**

DCs will ensure that "Good Samaritans" boards are displayed in all such hospital.

According to the "Good Samaritan Act", all private hospitals should give free treatment till the accident victim's condition stabilizes. The good samaritan should not be unnecessarily called for further enquiry. Wide awareness should be created on the lines of Supreme Court guidelines to protect "Good Samaritans" who help accident victims. This will encourage public to help accident victims.

**II. Traffic Education Park:** DCs (Traffic) have identified the following 5 places for construction of Traffic Education Parks. Officials of the Corporation of Chennai may explore possibility for construction of the parks at these places and furnish a feedback by 1.6.2017.

1. LG Road Park – Along the bank of cooum river.
2. Area along EB link road.
3. Corporation Park along Adams Road.
4. In Marina Beach, space near swimming pool.
5. Two-acre government land at Poonamallee.

**Action - Corporation of Chennai**

**III. Installation of CCTVs :** DCs (Traffic) have identified certain locations for installation of CCTV cameras (**Annexure II**). Officials of the Corporation of Chennai may go through the list and report feasibility of installation by 1.6.2017.

**Action - Corporation of Chennai**

**IV. Provision of Parking Zones:** DCs have identified the following places where parking can be provided both free as well as paid parking (**Annexure III**). Corporation officials may go through the list and report feasibility of implementation by 1.6.2017.

**Action - Corporation of Chennai**

**V. Encroachment Removal :** Corporation and police officials will liaise with each other and ensure that encroachments are removed in congested places identified by DCs / Traffic given in **Annexure IV**. The City Police is ready to provide necessary bandobust. The Commissioner, Corporation of Chennai may inform convenient dates for removal by 1.6.2017.

**VI. Raising height of centre medians and closing of gaps** : The existing centre median on Mount Road has been raised to 1.2 metres. Work on the remaining stretches will apparently be taken up and completed within 3 months. On completion of CMRL work, the balance stretches will be taken up.

**Delineators on Anna Flyover**: This work will apparently be taken up within a week. DCs-Traffic will report progress by 10.5.2017.

**VII. Improving illumination in Highways** : 41 places have been identified to improve illumination (**Annexure V**). Corporation officials and DCs (Traffic) may together visit the places ear-marked so that start work wherever possible may commence by 10.5.2017.

**VIII. Preventing school students (minors) from riding two-wheelers** : DCs will ensure that circulars are sent to all schools by 10.5.2017 cautioning minor students riding two wheelers to school.

**Action - DCs / Traffic**

**Road Safety Programmes** : DCs (Traffic) will meet school authorities and commence conduct Road Safety Programmes to create awareness. 1/3<sup>rd</sup> of the Schools in each DC-Traffic jurisdiction should be covered by 1.6.2017.

**Action - DCs / Traffic**

**Utilizing school ground for vehicles to pick up and drop children to reduce congestion** : Some schools have already been addressed in this regard. However, DCs (Traffic) should visit all schools and meet the school authorities to initiate necessary action in this regard atleast by 1.6.2017.

**IX. Conductor to be posted in all school buses/vans to ensure safety of children :** In order to avoid foot-board travel, drivers and conductors of MTC buses have been requested to keep automatic doors closed while plying. Police has been requested to impose fine against foot-board travelling.

MTC drivers should be advised to use bus bays wherever available. In Velachery, since a huge number of buses are plying in the area, drivers are not able to use the bus bay which results in halting of buses on the main road leading to traffic congestion.

**X. Teams for improving Road Engineering :** It has been decided to appoint a Nodal officer to form a committee consisting of officials from the Corporation, Highways, Electrical and Police department. They will visit places where road engineering has to be improved. Poonamallee bye-pass road, Avadi Bye-pass Road and CP Ramasamy Road require immediate attention and progress will be intimated by 1.6.2017.

**XI. Other Subjects for discussion :**

**Drunken Driving cases:** With regard to Drunken Driving cases, letter should be addressed to Transport Commissioner to find out the stage of cases pending for suspension / cancellation of licences. These details will be furnished by Addl.COP-Traffic to me by 10.5.2017.

Action - Chennai Police



**Traffic congestion near Schools and Colleges:** Recovery vans should be readily kept available for removal of break-down vehicles. Vehicles should not be allowed to be parked on roads near schools and colleges.

**Traffic congestion near hospitals:** Vehicles used for carrying patients should be parked only inside the respective hospitals. Ambulances should not be parked outside hospitals. Drivers should be warned of action in case they park ambulances outside hospitals.

Having received complaints about traffic obstruction due to parking of vehicles near Om Sakthi Hospital in Big Street and near Hindu High School (both sides) in Triplicane, DC (Traffic) will visit those places, take necessary action and report progress by 10.5.2017.

**Action - DCs / Traffic**

**Parking NOC for commercial establishments :** Traffic NOCs may be made mandatory for issuing trader licences for super markets, jewellery shops, textile show rooms, automobile show rooms, etc.

**Action - Corporation of Chennai**

**Road marking in Highways and Corporation Roads :** Road markings such as stop lines, pedestrian crossings, speed breakers, etc. should be constantly painted and maintained. Proposals for road markings may be collected from Traffic officers on a quarterly basis. The first list will be put up for my perusal by 10.5.2017.

In major roads, wherever there is enough space, parking bays can be provided. On roads with lesser space, parking can be provided near pavements. DCs (Traffic) will visit Anna Salai, Theagaraya Road, Poonamallee Road, Arcot Road, Usman Road, TTK Road, CP Ramsamy Road, Royapettah High Road, GP Road and other major roads and report possibility to provide parking space. They will furnish a feedback by 10.5.2017.

In the wake of complaints received about parking of vehicles on pavements, night rounds officers will make surprise visits and book cases against parking of vehicles on pavements. They will report progress through Addl.COP-Traffic by 10.5.2017.

It was reported that MTC buses slow down while using one-way stretch near Arunachala Naicken Street in Chintadripet, due to bad and congested roads. Young boys dwelling in the surrounding slums take advantage of this slow down and climb on such buses and cause a nuisance. Police along with Traffic, MTC and Corporation officials can visit the area, sort out the issue and report progress by 10.5.2017.

The meeting of the Chennai District Road Safety Committee was held today (4.2.2019) at 12.00 noon at the CoP conference hall, 8<sup>th</sup> floor, O/o the Commissioner of Police, Vepery, Chennai-7 to discuss road safety issues and remedial measures.

Thiru A.K.Viswanathan, IPS, Commissioner of Police & Chairman, The Chennai District Road Safety Committee presided the meeting. The following road safety issues were discussed in the meeting.

**A. Road safety week:**

1. The Ministry of Road Transport & Highways, Govt. of India has announced the observance of 30th Road Safety Week Campaign from 4th to 10th February 2019. The theme for this year campaign is Sadak Suraksha – Jeevan Raksha”.
2. All stakeholders are advised to take up awareness campaigns at all places. They are requested to organise awareness programmes / campaigns with innovative ideas for the benefit of public.
3. DC/Traffic (West) has come up with an idea of displaying a giant helmet on a vehicle and to take it to the city streets highlighting the importance of wearing helmet to preserve the precious human lives. Quiz programmes at vantage points on road safety to be organised during the helmet campaign.

**Action – All stake holders.**

**B. Guidelines to increase Good Samaritans:**

1. In all the Road Safety programmes, the role of good Samaritans is to be highlighted so that more people start helping the accident victims. Some of them can be honoured by Traffic Police.
2. The guidelines notified by the Ministry of Road Transport and Highways in this regard should be displayed at Community/ Primary Health Centres, all hospitals, public places and police stations for public view.
3. Addl. CoP/Traffic will issue a press release highlighting the fact that those whoever help accident victims will not be harassed and there is no need to hesitate to help the victims. This information to be aired in FM Radio to reach the public.

**Action – All stake holders.**

**C. Speed limit for vehicles:**

1. It was decided to continue the existing speed limit for various type of vehicles prescribed by the Commissioner of Police, Greater Chennai with the concurrence of State Transport Authority, Chepauk, Chennai-03, vide Rc.No. JCT/S1/587/18206/2002.

2. Sign boards indicating the speed limit in city/highway roads should be erected as per IRC norms.

**D. Road Safety Training for MTC , CMWSSB, and Corporation Drivers**

4. MTC/MWS&SB/Chennai Corporation will take up counselling/training sessions for contract vehicle drivers to prevent accidents. DCs, Traffic will coordinate with the concerned departments and organise programmes throughout the year without delay.

**Action- Corporation/ MTC /CMWSSB and DCs Traffic**

**E. Barricades on roads:**

Barricades put up on roads should be fitted with reflective tapes/LED lights etc. to catch the eyes of motorists at night. Those barricades without the lights should not be put up on roads for regulation of traffic.

**Action – DCs Traffic**

**F. Road improvement work:**

Addl. CoP/Traffic will send list of roads to Chennai Corporation/highways/PWD in which road engineering work and illumination should be taken up. The photos of such roads should be attached to the list. In turn, after completion of the listed work, the concerned department will send the photos for information.

**Action – DCs Traffic**

**G. Stray cattle menace:**

1. Chennai corporation and corporation/ municipalities concerned will attend to the issue of stray cattle menace at ECR (Akkarai, Injambakkam, Muttukadu), 200 ft. Radial Road (Mailai Balaji Nagar), OMR (Sholinganallur, Karapakkam, Pazhathotta salai) and Ambattur Subdivision (all roads).

**Action – Corporation**

**H. Driving licence cancellation:**

1. A web application or software for single window processing and tracking the D.Ls sent for cancellation / suspension in Six Head cases may be provided, so that police can file the proposal through online for cancellation of driving licence for violations under six heads.

**Action – Transport Department**

**I. General:**

1. It has been reported that lot of two wheeler accidents can be avoided if the motorcycles have both rear view mirrors. DCs, Traffic to ensure that awareness is created among the motorists.


2. Pedestrian path should be free from encroachments. Traffic Police and Chennai Corporation will co-ordinate and ensure that pedestrian foot paths are kept free from encroachment.
3. MTC has driving simulator to train their drivers on driving skills. Similarly, Chennai Corporation and CMWSSB are running hired contractual vehicles and hence they may take steps for procurement of such simulator to hone the driving skills to the drivers of the vehicles.

Greater Chennai Police will send proposals for purchase of simulator to train the drivers of police vehicles in the best interest of public. JC/Traffic (South) will follow up this.

4. The issues relating to widening of roads in the city to be taken up with the Chennai Corporation. This issue will be discussed at a separate meeting with the Chennai Corporation.
5. Lot of Government orders relating to road widening/acquirement of lands are pending for implementation. Addl. CoP/Traffic will give a note on this to take up the same with the Government during CS L&O meeting.
6. Helmet awareness campaigns should be taken up at different levels (Apartments, Corporate companies, Institutions etc.).
7. School children are affected due to dharnas/agitations near Pallavan House and unauthorised autos parking. It was requested to post a police constable to regulate the crossing of students. DC Traffic (East) will ensure this.
8. Photographs of students riding motor vehicles without licence or without helmet can be sent to the concerned DEOs for taking action. School Heads may be properly instructed in this regard.
9. Trees causing inconvenience to traffic flow can be uprooted and transplanted at another place. Chennai Corporation and Traffic Police will coordinate in this regard.
