

### ABSTRACT

### ORDER:-

In the Government order first read above, the Government had constituted the District Road Safety Committee and Chennai District Road Safety Committee under the Chairmanship of District Collector and Commissioner of Police, Chennai respectively to review the Road Safety measures in the Districts.

2) The Transport Commissioner In his letter 2<sup>nd</sup> read above has stated that, the Supreme Court Committee on Road Safety has suggested that in order to have the interaction with the State Governments more frequently and to attend all the meeting of the State Road Safety Council and District Road Safety Committee, it would be appropriate if the officers of National Highways Authority of India are notified as members of the Council and Committee.

3) In view of the above, the Transport Commissioner has suggested to include the Project Director, National Highways Authority of India as one of the member of the District Road Safety Committee and Chennai District Road Safety Committee. He has therefore requested the Government to issue necessary amendment to G.O first read above by adding the Project Director, National Highways Authority of India as member of the District Road Safety Committee and Chennai District Road Safety Committee.

4) The Government have examined the proposal of the Transport Commissioner in detail and decided to accept it. Accordingly, the following Notifications will be published in the Tamil Nadu Government Gazette.

ORDER:

The Govt in the G.O. 1st cited, have constituted the District Road Safety Committee and Krishnagiri District Road Safety measures that arise in this state and also considered is necessary to reconstitute the District Road Safety Committee statutorily in accordance with the provisions contained in the motor vehicle Act 1988 (Central Act-59 of 1988) and ordered to reconstitute the District Road Safety Committee under sub section (3) of Section 215 of the motor vehicle Act 1988 (Central Act-59 of 1988).

In the G.O.2<sup>nd</sup> cited, orders have been issued to nominate the Project Director NHAI, as members of this Committee. Accordingly the following are nominated in the District Road Safety Committee as follows.

The Government has also directed that the District Road Safety Committee shall meet regularly at-least once in a month reviews the following



1. To study and analyse the statistics relating to traffic accidents with reference to Black spots, nature of vehicles prone to accidents and other reasons for road accidents.
2. To review the action of the Police and Transport departments regarding cases for suspension of permits / licenses to look into Road re-engineering or other aspects for improvements:
3. To handle new schemes and inspection of design and construction techniques including the appropriate signage and other road furniture's:
4. To remove encroachments and obstruction affecting the full use of roads:
5. To undertake safety campaigns and vigorously motivate drivers to wear crash Helmet and fasten seatbelts in respect of persons travelling in motor cycle and car:
6. To introduce more effective and efficient licensing procedures and vigorously pursue the creation of the National Roaster for all Driving license holders:
7. To promote the establishment of adequate number of properly equipped driving schools:
8. To organize campaigns and orientation programmes for all categories of Road users and make them aware of their respective responsibilities:
9. To identify alternative measures for carrying out Road Safety activities at the District level:
10. To encourage private participation in the task of carrying out Road Safety Activates.
11. To promote involvement of Private Practioners in the Hospitals in Emergent Medical Response and Trauma care through training adequate safeguard and incentives.
12. To place the proposals before the District Road Safety Committee received from the user departments / agencies for seeking funds under the Road Safety Fund for its approval.

The Road Safety Committee meeting is bearing conducting every month at Collector Office, Krishnagiri under the Chairmanship of the District Collector and hereafter the venue of these meeting will be informed to all the concerned. The member secretary and all other members nominated above are requested to attend the meeting without fail.
