- The presentation of the Report was followed by a series of suggestions and queries from the public that can be summarised in the table below:

S.No	Suggestion/Comment	Answer

01	Nobody should be relocated, and slum areas should be provided with proper infrastructures.	Only the necessary areas which are under flood risk, will be relocated as per the policy/guidelines of the government.
02	Relocation would break communities and livelihoods.	The relocation will be suggested considering this suggestion.
03	Relocation houses do not fulfil human standards.	The standards of the relocation houses will be analysed as per government policies.
04	Relocated people should be consulted before relocation.	Suggestion will be incorporated and responsible Government Agency will take care of this.
05	Houses given to slum dwellers are very small and lack proper facilities. There is a general mistrust on TNSCB.	The standards of the relocation houses will be analysed as per government policies.
06	Lands near the river are given to corporates, but are not available to relocate people.	Maximum efforts are being done to find lands nearby, but always in areas out of flooding risk.
