  - Fund allocated and spent on road safety awareness.
  - Number of people challaned/fined for not wearing helmets while riding two-wheelers, not using seat-belt while driving four wheeler, over-speeding, drunk driving and other safety violations.
  - Number of driving licences that have been cancelled for serious driving offences.
