ORDER:

In the Government order first read above, the system of compounding of offences otherwise known as the spot fine system exercisable by the Police officers not below the rank of Inspector of Police was introduced in Chennai The spot fine system was extended to the cities of Madurai and Coimbatore in the Government order second read above. It was also ordered therein, that the Transport officials be allowed to exercise the power of compounding of offences in check posts on the lines of police officers exercising such authority. In the G.O third read above, the Government while extending the spot fine system to Tiruchirapalli have also doubled the rates of spot fine. Further in the said G.O. the Government have also authorized the Motor Vehicle Inspector (Non-Technical) in the check posts of the Transport Department in respect of the vehicles coming from other States and have also authorized the Police Officers not below the rank of an Inspector of Police having jurisdiction over the areas in the cities of Chennai, Madurai, Coimbatore and Tiruchirapalli other than the check posts of Transport Department to compound offences committed under the said Act. Subsequently, an amendment was issued to the notification issued in the G.O. third above by which officials of the Transport Department not below the rank of Motor Vehicle Inspector Grade-II having jurisdiction over the places other than the check posts shall exercise the power of compounding of offences in the places other than the check posts in respect of vehicles of other States.

- 2. In the G.O fifth read above, the Government have accepted the record of decisions submitted by High Powered Committee on 52 Recommendations of Tamil Nadu Police Commission (Third) under chapter II "Traffic Management" and the Director General of Police / Transport Commissioner was directed to send necessary proposals to Government.
- 3. Based on the above, the Transport Commissioner/ Director General of Police, Chennai in their letters seventh & eighth read above have sent proposals on the following recommendations of the Police Commission:-
 - (i) To extend spot fine system to all Districts.
 - (ii) To review the spot fine ceilings.
 - (iii) To authorize the Sub-Inspector of Police to collect spot fines.
- 4. The Government have examined the above proposals and decided to extend the spot fine system now in vogue in Chennai, Madurai, Coimbatore and Tiruchirapalli to all Districts in Tamil Nadu and to enhance the existing spot fines. The Government have also decided to authorize the officers of Traffic Police not below the rank of Sub-Inspector of Police (Traffic) in the Commissionerates and the jurisdiction officers including traffic police not below the rank of Inspector of Police in other parts of the State to levy spot fines. The Government have also decided to authorize the Motor Vehicle Inspector (Non-Technical) in the check posts of Transport Department and the Motor Vehicle Inspector (Grade-II) in their respective jurisdiction to levy spot fines. The Government have decided to issue a fresh notification in this regard. Accordingly, the notification appended to this order will be published in the Tamil Nadu Government Gazette.
