### **About CAG**

Citizen consumer and civic Action Group (CAG) is a non-profit and non-political organisation that works towards protecting citizens' rights in consumer and environmental issues and promoting good governance processes including transparency, accountability and participatory decision-making.

## **Project description**

There is one fatality every 4 minutes on Indian roads. The World Health Organization (WHO) notes that though India has only one percent of the world's roads, the country accounts for 10 percent of road accident fatalities. Reversing this worsening trend requires a concerted effort on various fronts – changing user behaviour; stronger legislation that covers aspects of vehicle safety, etc; better enforcement of legislation; proper road design and improved data collection regarding traffic. There is an ongoing effort to strengthen existing road safety legislation. The project has been advocating for this so India, as a signatory to the Brasilia Declaration, can meet its target of reducing road accidents by 50% by 2020.

The project aims to advocate for improved road safety in the country, with specific focus on Tamil Nadu (at the state- and district-level), through actions directed at key decision makers in legislative, implementation and enforcement agencies, and road users. The project will focus on analysing the current road safety situation in Tamil Nadu (from legislative and implementation perspectives) and work with relevant state agencies to identify and rectify any lacunae. This would require basic research and analytical skills to develop position papers on various aspects of road safety in Tamil Nadu. In addition, consultative meetings with stakeholders will be held and so the researcher must be able to liaise with various stakeholders to organise such meetings. The researcher would also be expected to have a good command of English and Tamil (spoken and written) as the work would involve contributing to position papers, blogs, articles, etc.

### Responsibilities

**Researcher - Road Safety** is a key position for developing our work on advocating for stronger road safety rules and to highlight a need for a change in road user behaviour.

The Researcher will be responsible for the following:

- Collecting, curating and analysing data
